Jason Norton, founder of Norton Financial, Inc. of Carrollton, has a donor advised fund at the Community Foundation of West Georgia. Norton said he was motivated to establish a fund because it is a very flexible and smart way to plan charitable giving.

"In the same way I believe in diversifying one's investments, I feel philanthropy through my fund allows me to support so many worthy causes that need our assistance and attention. The Community Foundation gives me great awareness of these causes so our fund has been able to support needs we might not have been aware of otherwise," he said.

"It is also nice to work with a local community fund where you get to know the people. The Foundation's team does a great job communicating and problem-solving, and they spend a tremendous amount of time on due diligence, which any donor/investor should appreciate," he added.

Norton received an economics degree at the University of West Georgia where a class on personal finance piqued his interest in that field. His firm celebrated its 20th anniversary this year with \$267 million in assets under management.

"As a first-generation college graduate, I really enjoy annual awarding of the Norton Financial Trailblazer Scholarship, which awards \$2,000 to a graduate of Central High School who also is a first-generation college student," he said. "Our family also has enjoyed supporting West Georgia Habitat and THS Emergency Shelter via our fund at the Community Foundation."

A LEGACY OF TRANSFORMATION; The Abundunt Grace Memorial Fund



When Bill and Lisa Travis' granddaughter Ralyx Grace passed unexpectedly during her freshman year of high school, the family wanted to do something meaningful to honor her loving spirit and to keep her memory and legacy alive in the community.

They decided to establish a donor advised fund at the Community Foundation of West Georgia called Abundant Grace Memorial Fund. Lisa had served on two Foundation panels reviewing grant requests and so was familiar with how serious the Foundation staff is in considering grant requests with dignity and thoroughness.

Lisa said that Ralyx was always a very giving person. "Even as a two-year-old in preschool she responded to those in need around her. There was a little boy with special needs in her class, and she took that child under her wing. Later in school she would worry about any underdog who the kids might be making fun of.

"When Ralyx passed away, we wanted to keep doing what we had watched her do, such as Christmas for those in need or making sure kids were able to go on school trips. Our fund gives us the flexibility to do that and it's easy to make grants" she said.



This would have been Ralyx's senior year at Bremen High School so that will be a focus this year for the family as they work with the cheerleading team and the special education department.

Lisa said that she hopes her other grandchildren will learn from Raylx's example to always give and to live every day to the fullest.

This single application is then fed into a sophisticated system where it is matched with the appropriate agency capable of meeting the user's needs. This innovative approach eliminates the need for individuals to fill out multiple forms and reduces the time spent searching for the right support.

How The Connector Works

Once a user submits their application, the Connector goes to work. The details provided help to identify the most suitable agency to address the individual's needs. If the matched agency can fulfill the request, they proceed to provide the necessary support. In cases where the agency is unable to assist, the request is redirected to another organization within the network, ensuring that no one falls through the cracks.

This matching process is both thorough and efficient. The Connector's system takes into account various factors such as the type of assistance needed, the urgency of the request, and the availability of resources at different agencies. By doing so, it ensures that every application is directed to the most appropriate service provider. This not only speeds up the process of receiving help but also increases the likelihood of successful outcomes for individuals seeking assistance.

Molding Passionate Active Creative Kids (M-PACK) provides top-tier services to children experiencing Adverse Childhood Experiences (ACEs). These programs bridge gaps caused by emotional and social neglect through engaging activities and life skills enrichment.

"I've always been involved with programs that were youth-centered and more specifically for youth that are considered at-risk." said Demarcus Copeland, Founder and Director of M-PACK. "The Bovs and Girls Club closing in our community really inspired me to launch M-PACK. Our community may not be as big as other urban areas, but our kids should always be given the same opportunities offered to other communities no matter the size."

M-PACK benefited from CFWG's invaluable guidance and support during its formation, laying the groundwork for successful partnerships. "When we began the paperwork to form M-PACK, the first person I reached out to was Kim Jones. She gave the best advice and has always been very helpful even in the form of email blasts!" Demarcus reminisced.

The On the Table initiative by the Community Foundation of West Georgia facilitated M-PACK's partnership with the Carrollton Housing Authority. Following a discussion on afterschool programming, housing authority employees sought collaboration, leading to M-PACK's move into a renovated building. The summer camp commenced on June 9, attracting 40 children, with new participants joining weekly. "When we started the program the housing authority was where we wanted to launch," said Demarcus. "So I was very excited and optimistic for this opportunity."

M-PACK plans to introduce services for parents, addressing accountability, security, and positivity, particularly for single-parent families. We asked Demarcus what advice he would give to other organizations looking to form similar partnerships through community initiatives. His answer was simple; be open to new creative ways to expand your impact. The M-PACK-Carrollton Housing Authority partnership, facilitated by the Community Foundation of West Georgia, significantly impacts the community, fostering youth growth and planning for a brighter future.


